Slaughter bulls were 2.00 higher. Demand and quality were both good overall. Supply included: 86% Feeder Cattle (39% Steers, 44% Heifers, 18% Bulls); 10% Slaughter Cattle (84% Cows, 16% Bulls); 4% Replacement Cattle (90% Bred Cows, 10% Cow-Calf Pairs).
