NOTICE IS FURTHER GIVEN that the Applicant in this Cause is requesting the following relief:

(a) An Order approving a multiunit horizontal well (the Blacktip 1H well) in the 1,280-acre horizontal drilling and spacing unit(s) formed for the Mississippian and Woodford common source(s) of supply in Section(s) 25, 26, 35 and 36, Township 13 North, Range 14 West and Section(s) 1 and 2, Township 12 North, Range 14 West, Custer County, Oklahoma so as to allow such multiunit horizontal well to be drilled as described in Paragraph 2(D) of the Application and to be completed in and to produce hydrocarbons from the above-named common source of supply. The Order should establish a proper allocation factor for allocating the cost of and the production and proceeds from such multiunit horizontal well to each of the affected units covered hereby.

## When law enforcement runs for office: The upside and downside of elected sheriffs

County sheriffs in Oklahoma occupy a distinctive role: they hold the badge, manage the jail, and stand on the ballot. Unlike most police chiefs or state troopers, the county sheriff in Oklahoma is an elected official.

Supporters argue that this gives citizens a say in how law enforcement operates in their region.

Critics contend it turns a grave public-safety job into another political contest.

Rather than focusing on voters holding the sheriff accountable at the ballot box, the more pressing concern is the financial liability the system has placed

on taxpayers. In recent years, Oklahoma counties have faced judgments and settlements totaling in the hundreds of millions of dollars as a result of actions tied to sheriff's offices and county jails. For example, in Ottawa County in Oklahoma the sheriff department lost a \$33 million judgment recently with the death of an inmate.

Because many sheriff's offices are essentially independent—answering directly to voters, not a statewide law-enforcement agency—some question whether the election model is the right structure. With mounting liability and scant oversight, the question of

On Monday, Amason submitted a letter to Cleveland County Clerk Pam Howlett formalizing his resignation with no mention of his criminal charges.

"Effective immediately, I hereby tender my resignation as the elected sheriff of Cleveland County. After 33 years of law enforcement service, the time has come for me to retire and begin the next chapter of my life," he wrote. "It has been one of the greatest honors and privileges of my life to serve the citizens of Cleveland County. I am sincerely thankful for the opportunity to serve this community and to work alongside the exceptional men and women of the Cleveland County Sheriffs

Office. I leave with sincere appreciation for their dedication, professionalism and commitment to public service."

A former Cleveland County Sheriff's Office employee had previously accused Amason of financial mismanagement. Teri Allison, previously the CCSO's chief financial officer, reached a \$55,000 sex-based discrimination settlement in 2024 with the agency after she alleged she was unfairly fired in favor of a less-experienced male employee.

Further, Allison alleged she was terminated after submitting a report that accused Amason of misconduct. Her report included allegations Amason had obtained equipment for the office

without filing purchase orders. She also alleged he and his wife had used CCSO funds for travel expenses — a claim reflected in one of the three counts the state dismissed in the terms of Amason's plea deal.

Amason denied Allison's allegations, according to The Norman Transcript's Mindy Ragan Wood. County commissioners approved the settlement, but District 1 Commissioner Rod Cleveland stated neither the county nor any official accepted liability by doing so.

Allison and Landon Russell, a former Cleveland County Jail employee arrested in 2023 on a drug charge, were listed on the grand jury's indictment as witnesses for the state.

Amason becomes the second Oklahoma sheriff indicted by a grand jury in the past year, following Coal County Sheriff Jason Smith, whose trial for removal from office has been pushed to November. Unlike Amason's prosecution, Drummond's office assigned Smith's prosecution to the Pittsburg County District Attorney's Office.

The Cleveland County commissioners jointly released a statement Monday afternoon and suggested they are still investigating how the process to replace Amason should commence:

Cleveland County Commissioners Rod Cleveland, Jacob McHughes and Rusty Grissom have been given a

copy of the resignation letter from Cleveland County Sheriff Chris Amason on Monday, April 27. The Commissioners have also seen the indictment from the multi-county grand jury filed today, which included multiple embezzlement claims.

The commissioners extend their gratitude to the multi-county grand jury and Attorney General's Office for their work on bringing these allegations to light.

During this time, the commissioners' top priority is protecting Cleveland County residents and ensuring essential services at the Cleveland County Sheriff's Office remain uninterrupted. The commissioners plan to individually seek guidance on next steps until they

are able to speak together in a public meeting in the coming days. As next steps are determined, they will be announced to ensure continued public safety, transparency and accountability.

Commissioners Cleveland, McHughes and Grissom are strong believers in justice. As elected officials, the commissioners believe they have a duty to be responsible stewards of every taxpayer dollar, and to follow the law — and believe the sheriff is no different.

First Florida Credit Union filed a civil case against Amason in December 2024 for civil relief worth greater than \$10,000 for indebtedness, but the claim was dismissed with prejudice in April 2025.
