

Suspect arrested by task force wanted in multiple states

An Oklahoma man jailed on prostitution and human trafficking charges involving two women has Arkansas and California outstanding warrants.

Christopher Don Jackson, 53, of Arkoma, is charged in Delaware County District Court with human trafficking and falsely personating another to create a liability, both felonies. He is also charged with aiding and abetting another with the intent to engage in prostitution, possession of a controlled dangerous substance – marijuana, possession of forged notes or instruments, and obstructing an officer, all misdemeanors. He remains in the Delaware County Jail.

Court records show he received a court-appointed attorney on Feb. 4 after telling the court he was indigent. He is to return to court on Feb.

18.

Jackson used a fake name and provided authorities a bogus date of birth, allegedly concealing his identity, according to an arrest affidavit.

When authorities confirmed his identity, they discovered he had outstanding arrest warrants from Siloam Springs, Arkansas, for forgery; Redwood City, California, for stolen vehicle; Fort Smith, Arkansas, for forgery; and Van Buren, Arkansas, for obstruction. Jackson also had a federal felony conviction for counterfeiting offenses.

Background

Jackson was arrested on Jan. 29. He is accused of transporting the two adult women from Arkansas to Oklahoma to a pre-arranged hotel for prostitution activity with an undercover agent.

Agents observed Jackson drop off



both women and remain nearby, waiting in or around the vehicle while the women entered the hotel. While the women were inside, Jackson was observed exiting the vehicle and walking to a nearby business before returning, behavior consistent with

overseeing or monitoring the prostitution activity, the warrant states.

Jackson was taken into custody, and agents found a counterfeit U.S. \$50 note in his pants pocket and a marijuana THC vape.
