A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WARR ACRES, OKLAHOMA CALLING AND AUTHORIZING THE COUNTY ELECTION BOARD OF OKLAHOMA COUNTY TO HOLD A PRIMARY AND GENERAL ELECTION IN THE CITY OF WARR ACRES, OKLAHOMA, FOR THE NOMINATION AND ELECTION OF: ONE COUNCILMAN, WARD ONE, TWO YEAR TERM; ONE COUNCILMAN, WARD TWO, TWO YEAR TERM; ONE COUNCILMAN, WARD THREE, TWO YEAR TERM; ONE COUNCILMAN, WARD FOUR, ONE YEAR TERM; ONE COUNCILMAN, WARD FOUR, TWO YEAR TERM, AND ESTABLISHING QUALIFICATIONS AND THE FILING PERIOD FOR THE FILING OF OFFICES OF COUNCILMAN OF THE CITY OF WARR ACRES, OKLAHOMA; AND PROVIDING FOR NOTICE OF ELECTION AND REGISTRATION FOR VOTING.

WHEREAS, pursuant to the Charter of the City of Warr Acres, Oklahoma, a primary election for the nomination of: Ward One Councilman, two-year term; Ward Two Councilman, two-year term; Ward Three Councilman, two-year term; Ward Four Councilman, twoyear term; Ward Four Councilman, one-year term, shall be held on the 10th day of February, 2026, and, if necessary, a general election be held on the 7th day of April, 2026.

WHEREAS, only qualified electors of the City who have resided in the City for one year and who reside in their respective wards from which they are elected shall be qualified for the office of Councilmen from the wards.

WHEREAS, it is necessary and expedient to establish the filing period provided by the Charter, and to request the County Election Board to conduct the election.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Warr Acres, Oklahoma, that the nomination: Ward One Councilman, two-year term; Ward Two Councilman, two-year term; Ward Three Councilman, two-year term; Ward Four Councilman, twoyear term; Ward Four Councilman, one-year term shall be held on the 10th day of February, 2026, and if no candidate receives a majority of the votes cast in the wards for Councilman at the primary election, then the Election Board is required to hold a general election on the 7th day of April, 2026, between the two candidates receiving the highest number of votes for each of the position Councilman, said Councilman to be elected by ward. The election will be non-partisan.

BE IT FURTHER RESOLVED that the filing period for the offices of Councilmen in the City of Warr Acres, Oklahoma, shall be from December 1, 2025 through December 3, 2025, during the regular business hours and days at the Oklahoma County Election Board. Candidates shall also file sworn statements of their candidacy with the City Clerk not more than one month and at least two weeks prior to the primary

BE IT FURTHER RESOLVED, that only qualified electors of the City who have resided in the City for at least one year shall be qualified for the office It is therefore ordered that said of Councilman. Additionally,

candidates for Councilman shall be residents of the wards for which they filed in the City of Warr

BE IT FURTHER RESOLVED that every qualified elector of the city shall be entitled to vote for one candidate for councilman from

BE IT FURTHER RESOLVED that the period during which new voters can register shall be through January 16, 2026. The provisions of Article 2, Section 2.1 of the Warr Acres Charter and Ordinance Numbers 171 and 621 shall govern this election insofar as its provisions are different from the provisions of the State law applicable to municipal elections.

BE IT FURTHER RESOLVED that the precinct officials and polling places for said election shall be determined by the Oklahoma County Election Board in the same manner as determined for State and County elections.

BE IT FURTHER RESOLVED that this Resolution shall be published in full and serve as notice of the election.

Dedication of Luper Plaza honors OKC as sit-in birthplace


Thousands gathered in downtown Oklahoma City this week to dedicate the Clara Luper National Sit-In Plaza, a permanent tribute to the Oklahoma City youth and teacher who ignited the nation's sit-in movement.

On Aug. 19, 1958, the original 13 student members of the NAACP Youth Council, led by schoolteacher Clara Luper, participated in a sit-in at Katz Drug Store. That act of courage resulted in the desegregation of Katz stores within three days and inspired a wave of sit-ins that propelled the Civil Rights Movement, advancing equal rights for all.

The newly dedicated art installation, located at North Robinson Avenue and West Main Street at the former Katz site, commemorates this historic moment with a lasting symbol: a 4-ton bronze lunch counter with realistic, life-sized depictions of the original 13 student "sit-inners," Luper and a Katz Drug Store employee.

The plaza's public dedication included musical performances by local choirs and remarks from Clara Luper's daughter, Marilyn Luper Hildreth; committee members the Rev. Dr. Lee Cooper Jr. and John Kennedy; Oklahoma City Mayor David Holt; and StudioEIS representative Elliot Schwartz.

Ten of the 13 original sit-inners attended, marking one of the most significant gatherings of participants in the past decade. Others who participated in subsequent sit-ins were also present.

situation. Bethany's utility billing is most comparable to Mustang, according to data provided by the city. Bethany's total billing figure is \$95.35, compared to Mustang at \$105.53. Yukon's is \$83.80, while Oklahoma City is \$111.18. However, Bethany's sales tax revenues are significantly smaller than like-sized communities.

Yukon has an estimated population of 27,300 and collected \$28 million in revenue from FY 2024. Bethany has a population of 20,100 and only collected \$6 million in local sales tax revenues. Mustang has a population of 24,500 and collected \$15 million. Warr Acres has less than half the population of Bethany at 10,200 and

collected more than Bethany in sales tax revenues at \$7

Ideas the city council discussed for future presentations for a sustainable budget included sales tax or a fee for capital improvements, fees for service on utility bills for everyone, reduced services and increased budget and fees.

project will fit within the remaining funding for the 2016 Library Bond. Staff recommended approval of the contract for an amount of \$128,400 for survey, geotechnical investigation, design and construction inspection.

The city retained TEIM Design to continue as its engineer of record. In other business, the city council discussed a proposed interlocal agreement between the City of Yukon and Bethany regarding the testing of water wells for potential sale to Yukon. According to the proposed agreement, aging

infrastructure and increased demand have made it necessary for Yukon to identify and develop additional and diversified sources of clean drinking water.

Because Bethany reportedly has a reliable source of clean drinking water, and a surplus of that water, the city will consider letting Yukon test three wells in Bethany located in the Garber Wellington Aquifer: Macrory Park at 50th and Peniel, water tank property at 32nd and Peniel, and Garrison Park at 19th and Mueller.

# Tulsa's Blue Team builds trust, breaks cycle of chronic homelessness

For nearly a decade, Staci Owens struggled to keep consistent shelter. The 53-year-old had confrontations with landlords, friends and shelter providers that resulted in bans from their properties. Her family relationships were strained, and a felony conviction complicated matters.

Owens lived in a tent under a bridge near downtown Tulsa that would occasionally get swept away with all her possessions by city officials. She always returned and rebuilt. She was diagnosed with depression and anxiety but said she doesn't believe those affect her much.

Things changed about two years ago when a member of the Blue Team, a newly formed outreach team at the Tulsa Day Center, developed a friendship with her. She was convinced to get off the streets, take medication regularly and work toward goals for permanent housing.

Three months ago, Owens progressed enough to be placed in a unit at a secured motel used as temporary housing by the Tulsa Day Center. She has decorated its walls with art she made, keeps her medical appointments and meets with the team at least once a week.

"I trust these people with housing more than the others because they promise not to let me go homeless," Owens said. "I believe that. They did fight for me. They did stick up for me."

The Blue Team is the first in the nation rooted in a method of outreach, shelter and treatment for people who are homeless, have a mental health disorder and show signs of anosognosia, a condition referring to patients who do not recognize they are ill.

While only 10% to 20% of the total homeless population are in this group, they place the biggest demand on community resources.

In Oklahoma, about 1,000 residents fall into this category. It's this group experiencing decades-long chronic homelessness and going through revolving doors of incarcerations, emergency room visits and involuntary

admissions for crisis care.

In September 2022, the Tulsa
Day Center created the Blue Team
from training provided by the LEAP
Institute, founded by psychologist
Xavier Amador. He launched a field of
research about 35 years ago, applying
anosognosia to mental health.

The Blue Team released its first outcomes data, which shows promising

In the team's first year, they spent time educating their partners about this new approach. Then, from September 2023 to Sep. 30, the team worked with 43 people meeting the criteria.

Of those, all but one remain in a stabilizing shelter. The group included 19 people finding long-term housing and treatment. The others are working toward goals to enter permanent housing but live in a motel room or at Tulsa Day Center.

All have consistent check-ins from a Blue Team member. The one person who returned to homelessness has since come back into the shelter.

Blue Team Director Kellie Wilson, a retired commercial banker, said she didn't want to put too much attention on the effort until the numbers backed up the work.

"I wanted solid data behind us," Wilson said. "When we set out to do this, the one thing I said is that we are not going to be the flavor of the day. We aren't going to go out there, be splashy and say, 'Let's do this or let's try that' and hope it worked

"This is the real deal," she said.
"We are continuing to learn. We haven't figured it all out. But we have enough data now that tells us we are doing something right. And, it also tells me that this can be replicated."

The method resembles more of a toolbelt than a formula, focusing on relationship building even when people are combative or resistant.

"This has allowed us to make a difference in places where we have been frustrated for years," Wilson said. "So for us to be able to make some headway is very important to us."

The critical piece of the Blue Team is understanding anosognosia. The term was coined in 1914 by neurologist Joseph François Babinski to describe

the symptoms of patients unaware of their paralysis, such as slurring words or not seeing that their limbs were immobile.

In 1991, Amador, a clinical psychologist on the medical school faculty at Columbia University's College of Physicians and Surgeons in New York, published a paper about anosognosia in patients with schizophrenia. That moved away from the belief that a person resisting treatment for a mental illness was doing so out of denial or stubbornness.

Anosognosia has been part of the Diagnostic and Statistical Manual for Mental Health Disorders by the American Psychiatric Association for 25 years. In 2000, Amador founded the LEAP Institute, which has trained thousands of professionals internationally.

for 25 years. In 2000, Amador founded the LEAP Institute, which has trained thousands of professionals internationally.

The traditional approach focused on convincing people they were sick and needed treatment. A person with anosognosia would often lash

out, insisting they were fine and

the problem lies with other people.

The LEAP method follows a listen, empathize, agree and partner model. The technique validates a person's beliefs to reduce conflict and move toward a common goal.

Several studies indicate that anosognosia affects about 60% of people with schizophrenia, 25% of those with schizoaffective disorders and 50% of people with bipolar disorder.

Michael Brose, the former executive director of Mental Health Association Oklahoma, came across Amador's work in the early 1990s and incorporated the research into staff training and family support groups. Now, the language and approach are expanding into areas such as law enforcement and homeless encampment decommissioning.

"What's really new are a number of groups that do outreach to the homeless putting anosognosia front and center," Brose said." I absolutely think this will have an effect statewide. Oklahoma City and Tulsa have collaborative, meaningful intercity sharing of
