ARTICLE I-"GENERAL" OF THE CODE OF ORDINANCES FOR THE CITY OF COLLINSVILLE, OKLAHOMA; PROVIDING FOR THE DISPLAY OF FLAGS AT CITY OF COLLINSVILLE FACILITIES; STATING THE PURPOSE AND INTENT OF THE ORDINANCE; IDENTIFYING THE SPECIFIC FLAGS AUTHORIZED FOR DISPLAY INCLUDING THE FLAG OF THE UNITED STATES, THE FLAG OF THE STATE OF

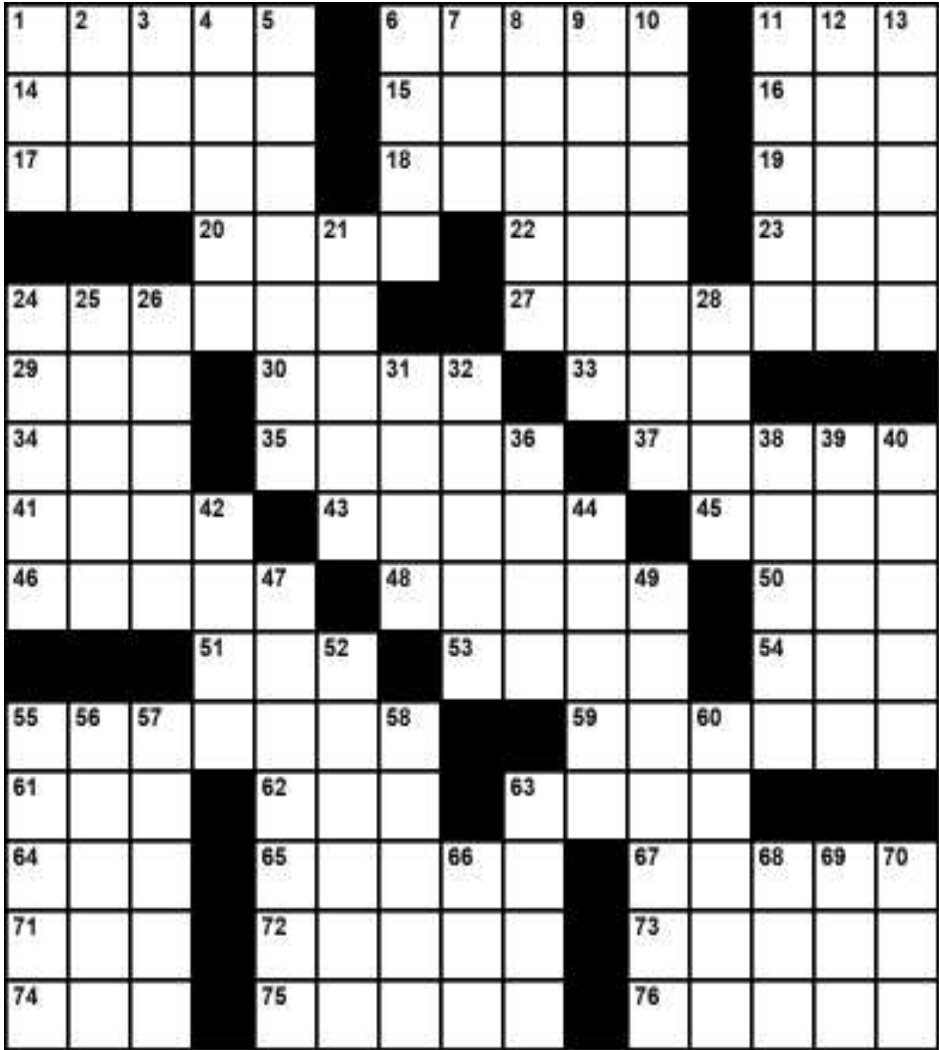
