

Lady Norse start season with home series sweep

The offense was firing on opening day of the 2026 Lady Norse softball season. NEO opened their spring schedule with Neosho County Community College on Thursday, Feb. 5.

Sophomore right-handed pitcher Morgan Barnes earned the win for game one, giving up only one hit and one run over five innings, with seven strikeouts. Freshman Ryan Amorosi came in for two innings in relief, giving up one hit and one run, and striking out two.

While Neosho scored first in the top of the first inning, NEO came right

back in the bottom of the inning and scored two, taking the lead and not looking back. The Lady Norse had a big offensive fifth inning, scoring four to seal the win.

Jadyn Helm led the offense with two hits, an RBI, and two runs scored. Kaydence Harjo and Torey Tedlock each added a hit apiece. Riley Kelly had an RBI sacrifice fly in the fifth inning, scoring Caylee Holcomb; while Tedlock followed it up with a three-run home run later in the inning.

NEO had a strong eye at the plate, accumulating seven walks for the game. Barnes and Bieber led the team

with two bases on balls each. NEO stole four bases in the game; Bieber had two; Holcomb and Kyler Howe each had one. The Lady Norse turned one double play in the game.

NEO came out even stronger offensively in the second game and wasted no time getting on the board in the first inning, scoring six runs. Four hole Addisen Hall scored Bieber (BB) and Holcomb (1B), getting the scoring started. Helm, Hall, Tedlock, and Howe would all come in to score in the bottom of the first.

The Lady Norse added one run in the second, when Tedlock hit a

sacrifice fly, scoring Holcomb. Four more NEO runs crossed the plate in the sixth inning to extend the lead to 13-5 and secure the win.

Hall hit a solo home run to center field, Peper hit into a fielder's choice, but one run scored, and Bieber singled, scoring two runs to end the ball game in run rule fashion.

Right handed freshman Gracie Macintosh earned her first career win for NEO. The starting pitcher gave up zero hits and zero runs over three innings, striking out two and walking four. Avery Johnson appeared in relief for three innings.

NORSEMEN LOSE PAIR OF NAILBITERS TO NOC-TONKAWA & MSC

The NEO Golden Norsemen hosted the Northern Oklahoma College-Tonkawa Mavericks in a Region II matchup Thursday night. NEO won the first meeting in Tonkawa on Jan. 5, 80-86. The Golden Norsemen needed to put a game in the win column after dropping two straight contests.

The game was a nailbiter from the opening tip with the two teams going back-and-forth to end the first half in a stalemate, 39-39. The Mavericks gained the edge in the second half, outscoring NEO 32-35. NOC-Tonkawa squeaked by NEO, 71-74, to steal the road win on the Norsemen's home court.

Sophomore star Justin McCarter led the Golden Norsemen offense with 17 points. McCarter also grabbed five rebounds in the loss. Reserve Landen

Simington added a career high of 16 points, six rebounds, one steal, and one assist. Freshman Demario Adams Jr. continued as a valuable sixth man with 11 points, seven rebounds, two steals, and one assist. Keyne Costa contributed 10 points, five rebounds, one assist, and three blocks.

The Norsemen shot 42.9 percent from the field, 26.1 percent from three-point range, and 73.3 percent from the foul line.

The loss brought NEO's overall record to 10-11, and 4-4 in Region II play. The Golden Norsemen needed to have a short memory. NEO hosted the Murray State College Aggies for an afternoon game on Saturday.

The struggles continued for the Golden Norsemen on Saturday. In what could have easily been a win, NEO dropped a game to the Murray State College Aggies by only two points, 88-90. The Golden Norsemen were in the driver's seat of destiny, having built a three-point

lead to enter halftime ahead 41-38. The Aggies kept pushing in the second half, outscoring NEO 47-52 to steal a Region II road game.

Standout shooting guard McCarter again led the NEO offensive attack with 19 points. He added eight rebounds, two assists, two steals, and one blocked shot. Barron Harris ended the contest with 16 points, one rebound, one assist, and two steals. Jed Ethan-Nansha scored 12 points, grabbed eight rebounds, and made two assists. Braeden Lloyd made a remarkable 10 assists.

The Golden Norsemen shot 55.4 percent from the field, 40.9 percent from behind the arc, and 70 percent at the foul line.

The loss drops NEO to 10-12 overall, and 4-5 in Region II play. NEO will host the Northern Oklahoma College-Enid Jets on Feb. 12.
