Savannah Bonham, Cami Wilson, Karissa Jones, Takota Ramirez, and Payton Deurloo each had two falls, with Grace Lickliter, AJ Waren, Sayben Owen, and Peyton Reaves, each getting one fall, and Adyson Nida adding a tech fall.

Junior AJ Waren, a regional finalist and 3rd place state medalist last year, opened her tournament with a fall in 0:42. Waren faced Tuttle state runner-up Liz McLeroy in the finals and took the early lead with a takedown midway through the first period. McLeroy managed to tie it at 3-3 after two period, but Waren took control from there, using a 3rd period reversal and near fall to claim the title with the convincing 9-3 win.

Maybe the most pleasant surprise of the tournament was the performance of Savannah Bonham. The freshman came into the tournament with three wins on the season, but was not to be denied as she opened with a fall in 2:49 to move into the finals. In the finals, Bonham led 4-0 before turning and pinning Bentonville West's Madelyn Lewallen in 4:37 to claim the 140 lb. title.

Sophomore Cami Wilson never went past the 1st period as she only wrestled a total of 1:40 to pin her two opponents and claim the 170 lb. title. Wilson




