Severe winter conditions continue to disrupt local blood supply

Although the winter storm has moved out of the region, lingering ice, snow, and sustained below-freezing temperatures continue to create hazardous travel conditions, resulting in ongoing challenges for healthcare systems and the local blood supply.

Since the winter weather began, 86 community blood drives have been canceled, resulting in the loss of more than 1,600 expected blood donations. With schools and universities remaining closed and donation opportunities still limited, Our Blood Institute is now missing an estimated 700 blood donations each day in educational drives alone.

These ongoing conditions are already impacting patient care. Our Blood Institute is experiencing significant shortages of platelets and O-negative blood, both of which are critical for trauma care, cancer treatments, and emergency surgeries.

Earlier this month, Our Blood Institute declared an emergency blood shortage as inventories fell to critically low levels. Thanks to donors who answered the call, donation levels began to improve and helped stabilize the blood supply. However, the prolonged effects of this winter weather have quickly erased that progress, thrusting the blood supply back into an emergency shortage once again.

Unlike a typical winter event where communities rebound within a day or two, many side roads and neighborhoods remain unsafe to travel several days later due to persistent ice and refreezing. Our Blood Institute has experienced significant staffing challenges as employees continue to navigate dangerous road conditions.

“When freezing temperatures linger, the impact on the blood supply compounds quickly,” said Dr. John Armitage, president and CEO of Our Blood Institute.



“We are incredibly grateful to the donors who stepped up earlier this month, but the reality is that even a few days of missed donations can quickly put patients at risk.”

All blood types are needed, with an urgent need for platelet donors and O-negative donors. Donation appointments remain available at Our Blood Institute donor centers for those who can safely travel.

Community members are encouraged to donate when conditions improve, and it is safe to do so to help stabilize the blood supply for patients across the region.

Anyone who is healthy and 16 years old or older can give blood. Donation typically takes

only about an hour, and one donation saves up to three lives. Appointments to donate can be made online at obi.org or by calling 877-340-8777. Walk-ins are also welcome. 16-year-olds must weigh at least 125 pounds and provide signed parental permission; 17-year-olds must weigh at least 125 pounds; 18+ year olds must weigh at least 110 pounds. Photo ID required.

Our Blood Institute is the sixth-largest independent blood center in the nation, with 17 donor centers in Oklahoma, Arkansas, and Texas. OBI is the nonprofit blood provider for patients at more than 240 hospitals, medical facilities, and air ambulances across all three states.

STATE AGS DEMAND xAI TAKE ACTION TO PROTECT CHILDREN

Oklahoma Attorney General Gentner Drummond and a coalition of 34 other state attorneys general are demanding that xAI, the company that owns both the X social media platform and the AI chatbot Grok, take action to prevent the chatbot from generating nonconsensual intimate images and child sexual abuse material.

The coalition wrote a letter issued on Monday, Jan. 26, calling on xAI to make immediate changes. They wrote, “You are investing tens of billions of dollars into developing powerful AI tools. In doing so, it is your obligation to comply with the law and devote sufficient attention and resources to avoiding the kind of widespread harms and abuses we are seeing now.”

In recent weeks, users have prompted Grok to “undress” women and children and to place them in sexualized contexts without consent. In some cases, Grok has generated images depicting children in minimal clothing or sexual situations. The coalition noted that xAI has marketed Grok’s permissive content generation as a selling point and warn that “the ability to create nonconsensual intimate images appears to be a feature, not a bug.”

“The protection of Oklahoma’s children and citizens from exploitation is non-negotiable. xAI has a responsibility to ensure its technology cannot be weaponized to create child sexual abuse material or nonconsensual intimate images,” Drummond said. “This company must act immediately to close these dangerous loopholes and demonstrate that user safety is more than an afterthought.”

Although xAI has recently implemented limited measures that appear to have reduced the volume of this content, the attorneys general are demanding assurances that these safeguards are effective and enforced. They are also urging the company to honor requests to remove this content, an action that will soon be required under the federal Take It Down Act, which goes into effect in May.

The attorneys general are demanding that xAI share how it intends to:

- Ensure that Grok is no longer capable of producing nonconsensual intimate images or child sexual abuse material.
- Eliminate such content that has already been produced.
- Take action against users who have generated this content.
- Grant X users control over whether their content can be edited by Grok.

Drummond is sending this letter alongside the Attorneys General of North Carolina, Utah, Pennsylvania, Connecticut, American Samoa, Arizona, Colorado, Delaware, District of Columbia, Hawaii, Idaho, Illinois, Kansas, Kentucky, Maine, Maryland, Michigan, Minnesota, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Dakota, Northern Mariana Islands, Oregon, Rhode Island, South Dakota, Vermont, Virgin Islands, Virginia, Washington, Wisconsin, and Wyoming.
