Notice is hereby given that the Oklahoma Department of Environmental Quality (DEQ) has issued a draft permit to supply reclaimed water to the Hennessey Utilities Authority (UA), 123 W.

Main St., Hennessey, Oklahoma, 73742. The draft permit to supply reclaimed water is based on a Tier II reclaimed water application filed on October 13, 2025, for a new permit with DEQ. The Hennessey Wastewater Treatment Facility (WWTF), which is located in the NW 1/4, NE 1/4, SW 1/4 of Section 23, Township 19 North, Range 7 West, IM, Kingfisher County, Oklahoma, is a municipal facility that accepts domestic wastewater. The final permit to supply reclaimed water, if issued, would allow the Hennessey UA to supply treated municipal wastewater, also known as Category 5 reclaimed water, from the Hennessey WWTF. The reclaimed water shall be used for irrigation on pasture land, located in S 1/2, SE 1/4 of Section 23, Township 19 North, Range 7 West, and W 1/2, NE 1/4 of Section 26, Township 19 North, Range 7 West IM, Kingfisher County, Oklahoma.
