



Crime targeted in northeast Oklahoma by multi-agency operation

A large-scale, four-day enforcement initiative targeting violent offenders, wanted felons, narcotics trafficking, and street level criminal activity throughout northeast Oklahoma has concluded with significant results.

The Bureau of Indian Affairs (BIA) Office of Justice Services, Division of Drug Enforcement (DDE), in partnership with federal, state, county, and tribal law enforcement agencies were involved and operational activities centered on major transportation corridors, like Highway 412 and Interstate 44, that have been exploited for drug transit, criminal movement, and the distribution of illegal narcotics.

Enforcement efforts took place across the sovereign lands of the Quapaw, Miami, Peoria, Modoc, Ottawa, Wyandotte, Eastern Shawnee, Seneca Cayuga, and Cherokee Nations.

The operation brought together a broad coalition of partner agencies, including:

- Bureau of Indian Affairs – Division of Drug Enforcement
- District 13 Drug and Violent Crimes Task Force
- Ottawa County Sheriff's Office
- Delaware County Sheriff's Office
- Tribal law enforcement from the Quapaw, Miami, Wyandotte, Eastern Shawnee, Cherokee, and other tribal nations
- Oklahoma Highway Patrol
- Oklahoma Bureau of Narcotics
- Municipal agencies including Miami Police, Grove Police, Jay Police, and West Siloam Springs Police
- Federal support from the Drug Enforcement Administration (DEA) Tulsa Office

The coordinated operation conducted Jan. 14–17 focused on high crime corridors across Ottawa and Delaware Counties, and involved a unified deployment of resources from more than a dozen partnering agencies, with the goal of enhancing public safety and disrupting criminal networks operating across jurisdictional boundaries.

The initiative was designed to aggressively suppress criminal activity through intelligence-driven enforcement. Key objectives included:

- Targeting known violent offenders and wanted felons
- Disrupting narcotics trafficking networks
- Increasing visibility in high crime areas to deter criminal activity
- Identifying drug distribution locations and persons of interest
- Enhancing collaboration among federal, state, county, and tribal agencies

"This level of cooperation reflects our shared mission to safeguard our citizens and communities in Miami and surrounding jurisdictions," said Miami Chief of Police Stephen Sigmon. "No single agency can address these challenges alone. Our partnerships are essential to success."

Daily briefings were held to share updated intelligence, including wanted subjects, high crime zones, and locations linked to ongoing investigations. Saturation patrols, targeted interdiction, and surveillance components were deployed to areas identified as high risk. Coordination protocols, and interagency dispatch systems were established prior to deployment to ensure safe and effective operations.

The multi day initiative reinforced law enforcement presence throughout the region and demonstrated the collective commitment of federal, state, and tribal partners to safeguard their communities. Real time intelligence sharing and cross commissioning allowed officers to operate lawfully and effectively across multiple jurisdictions.

Over the four-day period, the multi-agency team carried out saturation patrols, targeted interdiction efforts, surveillance operations, and coordinated warrant service, resulting in substantial enforcement outcomes.

- Traffic/citizen contacts: 146
- Vehicle searches: 55
- K-9 deployments: 14
- K-9 alerts: 12
- Citations issued: 17
- Arrests made: 31
- Firearms seized: 18

Total Drug Seizures:

- Methamphetamine: 121.77 grams
- Heroin: 0 grams
- Fentanyl pills: 0 pills
- Cocaine: 43.7 grams
- Marijuana: 4,126.7 grams
- Prescription pills: 1 pill
- LSD: 0 grams

Agencies anticipate further activity as intelligence continues to develop. Additional enforcement actions and follow up investigations are ongoing.


