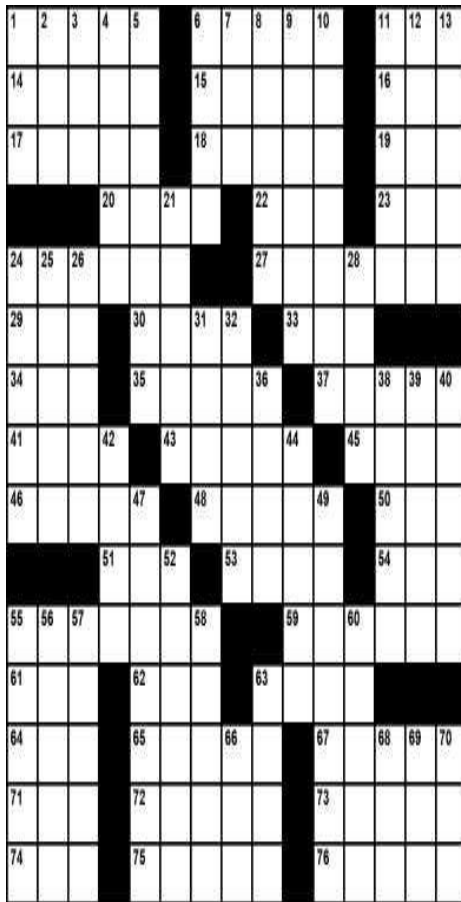

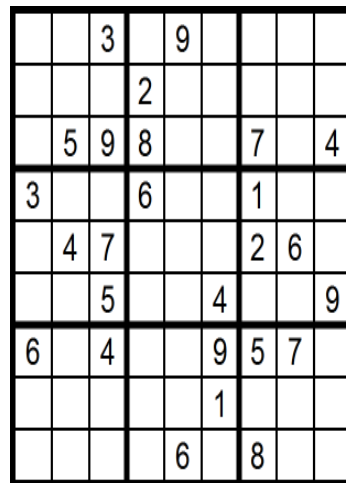

S U D O K U
