The work generally consists of furnishing all labor, materials, equipment, and incidentals necessary to rehabilitate existing water treatment plant filters, adsorption clarifiers, and associated treatment components, including, but not limited to, the following:

Base Bid - Filter No. 4; Rehabilitation and repair of the existing filter structure. Removal and disposal of existing filter media. Removal and replacement of the existing underdrain system. Furnishing and installation of a new filter air scour system, including associated piping, valves, and appurtenances. All related mechanical, structural, and miscellaneous work necessary for a complete and operational installation.
