The Oklahoma Election Board mails 71,000 postcards to voters who have submitted Change of Address filings at the post office.

## State mails postcards to voters requesting address information

This week, the Oklahoma State Election Board mailed postcards to more than 71,000 voters requesting that they update their voter registration address.

State Election Board Secretary Paul Ziriaux announced the postcards were mailed to voters who were identified by the U.S. Postal Service as having completed a National Change of Address Card within the past 12 months.

Election officials say the effort helps ensure clean voter registration rolls and is part of the State Election Board's regular voter list maintenance process.

Voters who receive the postcard should log into the OK Voter Portal to update their voter registration

address or complete a paper Voter Registration Application, and submit it to their county election board.

Ziriaux said it's important that voters update their registration as soon as possible. "Next year is a big election year with both state and federal offices on the ballot. We recommend that voters act now. Remember, if you have moved to a new address, you will need to update your voter registration," said Ziriaux.

State law requires voters to register to vote at their place of residence.

Instructions for updating registration and voter registration deadlines can be found on the State Election Board website. Voter list maintenance is required by both state and federal law.
