Summers stated that she found out that the emergency management program grant was delayed due to the government being shut down but they are hoping that it will be cleared up soon. Summers stated she talked to the safety guy at ACCO and he stated that ACCO has asked him to be more present in the counties to discuss safety. Summers stated she will have to have a tire looked at since it is saying she has a low tire. Wesson questioned if she had heard anything about the radios.
