Stat. tit. 10 § 7505-4.2 (B).

Petitioners have also alleged in the Petition that said minor child is eligible for Adoption in that the alleged natural mother abandoned the child, therefore, Okla. Stat. tit. 10 § 7505-4.2 (G) applies.

Petitioners have further alleged in the Petition, that the natural mother has failed to establish and/or maintain a substantial and positive relationship with the minor child pursuant to Okla. stat. tit. 10 § 7505-4.2(H)(1).

Perry Rotary hears airport updates

The Perry Rotary Club met Monday, January 12, and opened the meeting with several announcements regarding upcoming schedule changes and community events. Members were reminded there would be no Rotary meeting the following week, and that the next meeting would take place at the hospital, where Rotarians would meet downstairs for a presentation and tour. Dennis Steichen was thanked for coordinating the visit, and members were informed that a head count would be requested by email prior to the meeting.

Members were also informed that tickets for the Chamber of Commerce Banquet went on sale January 12. The banquet was scheduled for February 19 at the fairgrounds and was set to include music and dancing following the event.

Student Rotarians also reviewed recent and future school activities at Perry High School. On Monday, January 12, there were no scheduled events. On Tuesday, January 13, high school boys wrestling competed at Cushing, high school basketball hosted Chisholm for homecoming, and the FFA Blue and Gold kickoff occurred. There were no scheduled activities on Wednesday or Thursday. On Friday, January 16, high school boys wrestling competed at the Catoosa Tournament, and junior high PTOC activities took place.

The program featured Terrence Hulet, Perry Airport Manager and former Junior Rotarian. Hulet had served as airport manager for five to six years and was a Perry native who graduated from Oklahoma State University with a professional pilot degree. Prior to his current role, he worked as a flight instructor and in corporate aviation, joking that his path to airport management began when business was slow and he

stopped by the airport simply looking to mow there grass. Hulet provided updates on several airport improvement projects. One of the first upgrades completed during his tenure was the installation of a self-serve fuel system, allowing pilots to fuel aircraft independently. Since its installation, fuel sales had increased and accessibility for visiting pilots improved.

Another major project involved filling a large drainage ditch on the north end of the airport, opening space for future hangar development. At the time of the meeting, the airport had 28 hangars, with plans underway to increase the number of city-owned hangars to approximately 30. New hangars under construction were 450-by-50-foot units, partially funded by the state, with rental rates expected to range from \$450 to \$550 per month. Demand remained high, with a waiting list of approximately 30 pilots.

Hulet also discussed long-term planning efforts, including a full runway renovation anticipated for 2030–2031. The estimated \$4 million project was expected to be funded primarily through federal and state programs, with the city responsible for approximately 5 percent of the cost. Surveyors had been actively assessing the runway in preparation. Once completed, the renovation was expected to extend the runway’s lifespan by at least 20 years.

The Perry Airport averaged 17,000 to 20,000 aircraft operations annually, including training flights from Oklahoma State University and seasonal aerial applicators. Hulet noted the airport served both local pilots and those from surrounding communities, including Stillwater, Cushing, and Enid.

Hulet also reflected on the success of the airport’s October air show, which had drawn more than 1,300 visitors. The event featured a car show, fly-in aircraft displays, food

trucks, and live music. City officials and airport staff planned to continue the event annually as part of efforts to promote the airport as a community asset.

During the question-and-answer portion of the meeting, Hulet discussed the airport’s World War II-era origins, its 5,100-foot runway, emergency landings, and partnerships with Perry Public Schools’ aviation program. While emergency landings had occurred on rare occasions, Hulet noted they were uncommon and typically managed without serious incident.

Hulet concluded by emphasizing continued growth at the Perry Airport through expanded hangar space, business development, and increased community involvement.

Maroons fall to Cushing, Alva at Wheat Capital Tournament

The Perry Maroon boys basketball team dropped a pair of games Friday and Saturday at the Wheat Capital Tournament, falling to the Cushing Tigers and the Alva Goldbugs at Chisholm High School.

On Friday, Perry faced Cushing and found itself playing from behind early. The Maroons scored 10 points in the first quarter, led by Derek Trotter’s basket and free throw, a 2-pointer from Elliott Milligan, two free throws from Zane Wolfe and a basket by Kian Thompson. Cushing jumped out quickly, scoring 20 points in the opening period.

Perry gained momentum in the second quarter, putting up 21 points. Trotter added two free throws, while Milligan and Wolfe each knocked down a 2-pointer and a 3-pointer. Heston Witter sparked the offense with a 3-pointer and six free throws. The Tigers still held a 35-31 halftime lead after scoring 15 points in the quarter.

The Tigers surged again in the third, scoring 25 points. Perry countered with 16 points behind baskets from Trotter, Milligan, Wolfe and two 3-pointers from Witter. In the fourth quarter, Perry held Cushing to 11 points, but could not fully close the gap. Saturday, the Maroons continued tournament play against Alva. Perry scored 11 points in the first quarter with contributions from Trotter, Milligan, Wolfe, Thompson and Witter, but Alva led 16-11 after one.

Perry added eight points in the second quarter, including a 3-pointer from Trevan Tabbert and scoring from Witter and Trotter, but Alva maintained control with 18 points to take a 34-19 halftime lead.

The Maroons kept pace offensively in the third quarter, scoring 14 points behind a strong stretch from Trotter and Witter. Alva again matched the effort with 18 points.

Perry’s best quarter came in the fourth, when the Maroons poured in 24 points. Trotter scored both inside and from long range, Nathan Ford hit a 3-pointer, Thompson added a basket and free throw, and Witter scored 11 points in the period. Despite the surge, Alva answered with 19 points to secure a 71-57 victory.
