solution bracket of the 3A playoffs. Casady used a 28-6 run in those second eight minutes to earn a 74-51 win over the Eagles on Friday. The loss has Hennessey one win from elimination and needing three wins this week in a regional to advance to area. The first shot comes at 7:30 p.m. Thursday when the Eagles host winless Sperry in a consolation quarterfinal. The rest of the regional will be played at Millwood.
