Commissioner Tim Tipton awarded Governor's Medal of Valor

On Tuesday, Feb. 10, Oklahoma Governor Kevin Stitt presented Commissioner Tim Tipton with the Governor's Medal of Valor in recognition of his decades of devoted service and many contributions to public safety. "On behalf of all four million Oklahomans, I can tell you this: We stand by our law enforcement and support those who protect our communities and our families. I am grateful to my friend, Commissioner Tim Tipton, for his tremendous service to the state of Oklahoma," said Stitt. "He has navigated unprecedented public safety challenges with professionalism, precision, and courage, foreseeing threats and positioning state law enforcement to address them before they can endanger Oklahomans. "He implemented a first-in-the-nation approach to smart, targeted immigration enforcement through Operation Guardian, working with federal authorities to apprehend dangerous criminals present in our state illegally. Because of that effort, Oklahoma is third in the nation for the removal of dangerous criminals in real numbers. He has worked tirelessly to protect Oklahomans and support federal

law enforcement without requiring their direct presence. Oklahomans are safer because of his leadership." During the special ceremony surprising Commissioner Tipton with the award, Governor Stitt also announced efforts underway to name a future law enforcement training facility the Tipton Training Center, honoring the Commissioner's legacy for decades to come. "After almost five years in this job and nearly 38 years with the agency, this training facility is something many of us have dreamed of for our entire careers," said Commissioner Tipton during the event. "It's the biggest honor of my life. It has been an incredible privilege to serve as Commissioner, and there's no better way to end a career than by leading the most professional group of law enforcement officers in the country."

BILL STRENGTHENING LOCAL FOOD NETWORKS HEADS TO FLOOR

With bipartisan approval from the Senate Agriculture and Wildlife Committee, legislation to encourage and promote more local farming throughout the state, including urban areas, is now headed to the Senate floor. Senate Bill 2061 by Sen. Nikki Nice (D-Oklahoma City) will create the Oklahoma Food Policy Council. "The ultimate goal is to coordinate efforts related to food policy in this state and strengthen our local food networks. Through SB 2061, we can connect our local producers, farmers, urban gardens, community gardens, and farmers markets to make it possible for more Oklahomans to enjoy locally grown, healthy foods," Nice said. Under SB 2061, the governor, speaker, and pro tem would each appoint three members to the Oklahoma Food Policy Council, which will advise the Department of Agriculture on creating networks of farmers to provide sustainable, locally grown food, strengthening coordination between existing programs, and assessing the impact of production of sustainable food distributed locally. "The legislation will help us create stability and remove barriers to growers, drive demand through the promotion of 'Oklahoma Grown' produce, and increase visibility and support for locally grown products," Nice said. "I also believe this program can help Oklahoma address the problem of food access across the state, where residents have low availability of fresh fruit and vegetables. I appreciate the support from members of the committee and the chair, Senator Casey Murdock, and look forward to presenting SB 2061 to the full Senate."
